## Lifeguard Job Description

**Minimum Qualifications:** Age 15, Red Cross Lifeguard Training, Red Cross First Aid, Red Cross CPR for the Professional Rescuer or equivalent certification that meets or exceeds these requirements.

**Desirable Qualifications:** Water Safety Instructor certification; Lifeguard, First Aid, CPR Instructor certification, previous life guarding experience, work experience such as cashier, cleaning, etc...; related work with children

**Job Description:** The lifeguard will be responsible for the safety and supervision of pool patrons, including enforcement of pool rules and policies; including enforcing pool regulations and policies; will assist with the daily cleaning and maintenance of the pool and bathhouse areas; will assist with admissions and other chores associated with the community pool; will administer first aid and emergency (as needed); and will complete required forms and paperwork. The lifeguard will comply with all pool rules and policies and complete other reasonable pool related work as assigned, directed by the manager.

## Instructor Job Description

**Minimum Qualifications:** Age 16; Red Cross Lifeguard Training, Red Cross First Aid, Red Cross CPR for the Professional Rescuer; Red Cross Water Safety Instructor; or equivalent certification that meets or exceeds these requirements

**Desirable Qualifications:** Previous Red Cross affiliation; previous teaching experience, related work with children

**Job Description:** The swim lesson instructor will teach swimming and water safety, including the planning, supervision and evaluation of participants in compliance with the policies of the Red Cross learn-to-swim program.

**NOTE:** All applicants must furnish documentation in the form of original, current certificates, Instructors must be authorized, or be able to secure authorization, with Sioux Land Red Cross. No pool employee will be allowed to work with expired or missing certificates.
